Focus Group Explored Work-From-Home Policies

Human Resources professionals from seven LPCs came together as part of a focus group to discuss the pros, cons and best practices of hybrid and work-from-home policies.

The focus group evolved following a member request for information on accepted work-from-home (WFH) practices and what policies had been implemented by other LPCs. Director of Member Engagement Kari Crouse released a survey to TVPPA members to get more information on who had WFH policies or hybrid work schedules in place and then volunteers were solicited to share ideas on this important issue.

Facilitated by TVPPA Communications Coordinator Jake Harrison, the group discussion identified a clear need for more flexible workplace policies. They cited a growing demand for hybrid and pure WFH options that offer a greater work/life balance. Much of this demand stems from COVID office closures proving that WFH can be a valid option as well as changing demographics. Balance and flexibility are highly valued by younger workers and with competition for talented employees at all-time highs, rigid and inflexible policies related to remote work can stand between your organization and the best talent. The group did note that flexible work options are a privilege and it is incumbent upon managers to monitor productivity and to communicate with employees if productivity is suffering due to remote work.
